

Moreover, the pluralism of the economic criminal law also allows the illegal use of authority like the erosion of executive power towards judicial power, and the usurpation of judicial power towards legislative power. The application of norms of the economic criminal law should be conducted after the constitutional review of low ranking non-criminal norms on the principle of legality. This book gives feasible solutions on choosing suitable law when there are contradictions between civil and criminal law, and gives suggestions on the constitutional review of illegality. It is of great theoretical creativity and practical value.
